"Where a transmission company and a landowner or occupier cannot enter into a voluntary access agreement (access agreement), a transmission company may exercise existing statutory powers under section 93 of the Electricity Industry Act 2000 (Vic) (the Act), to access private land to plan, design and construct new assets." 30 November 23 Essential Services Commission, which is completely unacceptable because it wilfully and wrongly takes away landowner's rights to say NO to the 220kv dangerous and hazardous transmission lines being put on his or her property and being forced to deal with the high bushfire risk, chemicals from the transmission lines leaking into the ground and unfairly, not to mention, unnecessarily grievously changing the landowner's landscape, which is highly likely why they bought the land in the first place.
