Goulburn-Murray Water price review 2024


We recently held a hybrid public forum at South Shepparton Community Centre as part of our review of Goulburn-Murray Water's proposed prices and service priorities for the next four years.

It was a great opportunity to hear from stakeholders as their feedback will help inform our final decision.

Our draft decision remains open for feedback until 7 May 2024 with the final decision on prices to be released in June 2024.

Utility Regulators Forum

Our staff and leaders attended the Utility Regulators Forum to hear from and collaborate with fellow regulators in different jurisdictions.

Revoking the Electricity System Code

Following engagement with stakeholders, we published our final decision to revoke the <u>Electricity System Code</u> – a regulatory instrument established in 2000.

The code contains obligations for Victorian electricity transmission and distribution businesses. The National Electricity Rules and the National Electricity Law now largely regulate these. Revoking the code will streamline obligations and reduce complexity of Victoria's energy regulatory framework.

Revocation of the code will take effect on 31 May 2024.
