Failed gas retailer Weston Energy pays penalty after allegedly failing to meet energy efficiency liabilities

Former gas retailer <u>Weston Energy Pty</u> <u>Ltd (Weston Energy) has paid a penalty of</u> <u>\$53,600</u> after allegedly failing to surrender enough Victorian energy efficiency certificates to offset its legislative liability under the <u>Victorian Energy Upgrades</u> <u>program</u> in 2022.

# Our latest progress report on breaking down barriers to essential services

Supporting Victorians experiencing vulnerability to have equitable access to energy, water, transport and other critical services remains a key focus for us amid growing cost-of-living pressures for consumers.

We have released a <u>progress report</u> on our <u>'Getting to fair' strategy</u> aimed at breaking down the barriers Victorians may face in accessing or engaging with regulated essential services.

The strategy has helped us to keep the experiences, needs and expectations of consumers experiencing vulnerability at the centre of our work program and regulatory decisions. At the two-year mark, we have implemented 21 of the 33 actions we committed to undertake.

Unbooked taxi fares to increase following annual adjustment for fuel and labour costs

<u>Maximum fares for unbooked taxis</u> will increase 4.1 per cent from 1 October 2023 following an annual fare adjustment.

This adjustment is driven largely by increases in labour costs following the Fair Work Commission decision in June 2023 to increase the national minimum wage by 8.6 per cent. The higher labour costs have been offset slightly by a fall in fuel prices in the year to June 2023.
