

## Independent Auditor List

Version 1.4 – 18 February 2025

On 1 July 2023, changes to the Victorian Energy Upgrades (**VEU**) program came into effect. Pursuant to section 55L(1) of the Victorian Energy Efficiency Target Act 2007 (**The Act**), the Essential Services Commission (**commission**) is required to publish and maintain a list of independent auditors on the commission website.

Pursuant to section 55L, the commission has assessed the auditors on the list below and is satisfied that the auditors have the relevant skills, competencies and qualifications and have undertaken training or have sufficient knowledge or experience in relation to the VEU program to conduct the audits specified in Schedule 1 to this notice. The category of audits that the auditor is able to undertake is marked with a cross the Auditor category of the schedule.

The commission does not make any representations about the quality of services provided by auditors on the independent auditor list. Inclusion on the list signifies that the commission has assessed them as meeting the criteria outlined in section 55L(2) of the Act. Accredited persons should make their own assessment of an auditor as to their suitability to conduct the relevant audit.

The commission may remove an auditor from the list of independent auditors if the commission believes on reasonable grounds that the auditor no longer satisfies the requirements to conduct the audits or has contravened a requirement of the Act or Regulations or guidelines made under the Act.
