

## ELECTRICITY INDUSTRY ACT 2000 APPLICATION FOR ELECTRICITY GENERATION AND SALE LICENCE

# Regional Wind Farms Pty Ltd ACN 107 163 182

**RECORD OF DECISION** 

7 August 2024

#### **SUMMARY**

Pursuant to the provisions of section 19(1) of the Electricity Industry Act 2000 (Vic) (Industry Act) the Essential Services Commission (the commission) has granted Regional Wind Farms Pty Ltd (ACN 107 163 182) (Regional Wind Farms) a licence to generate electricity for supply or sale at the Wonthaggi Wind Farm (which is located in the vicinity of Wonthaggi, Victoria and has a total nameplate capacity of 12MW) and to sell the generated electricity through the wholesale electricity market.

#### **BACKGROUND**

Section 16(1) of the Industry Act provides that a person must not engage in the generation of electricity for supply or sale or the transmission, distribution, supply or sale of electricity unless the person :

- (a) is the holder of a licence authorising the relevant activity;
- (b) is exempted from the requirement to obtain a licence in respect of the relevant activity; or
- (c) is the holder of a trial waiver in respect of the relevant activity.

Section 18(1) of the Industry Act provides that a person may apply to the commission for a licence authorising the person to generate electricity for supply or sale and to sell electricity (under subsections (1)(a) and (d)).

On 27 February 2024, Regional Wind Farms applied to the commission for a licence authorising it to generate electricity for supply or sale, and to sell electricity through the wholesale electricity market.

Consistent with the requirements of the commission's electricity generation licence application form and 'Guideline: Applications for electricity and gas industry licences', Regional Wind Farms provided the commission with necessary documentation supporting the application.

On 17 June 2024, the commission published a copy of the application, and invited interested parties to make submissions in respect of the application. The commission did not receive any submissions regarding the application.

### **CONSIDERATION OF THE APPLICATION**

Section 19(1) of the Industry Act provides that the commission may grant or refuse the application for any reason it considers appropriate, having regard to the objectives of the commission under the provisions of the Industry Act and the Essential Services Commission Act 2001 (Vic) (Commission Act).

#### **DECISION**

The commission is satisfied that:

- Regional Wind Farms has the technical capacity to comply with the conditions of the licence to be granted; and
- Regional Wind Farms is a fit and proper person to hold a licence to generate electricity for supply or sale, and to sell the generated electricity through the wholesale electricity market in Victoria.

In accordance with Section 19(1) of the Industry Act, and having regard to its objectives under the Commission Act and the Industry Act, the commission has decided to grant Regional Wind Farms a licence to generate electricity for supply or sale and to sell electricity through the wholesale electricity market. The authorisation granted by the licence is limited to the generation of electricity at the Wonthaggi Wind Farm located in the vicinity of Wonthaggi, Victoria, and the sale of electricity generated by this facility through the wholesale electricity market.
